Awakening Through Race, Intersectionality, and Social Equity Report to North American Dharma Teachers Sangha, March 2018 "Creating Inclusive Community"

Dear Beloved Community,

We are at a pivotal moment in our Mahasangha life. With deep awareness that we are Thay's continuation, this is a tremendous opportunity to reflect and to shape our Mahasangha future. Imagine attending a Sangha, a daylong, or retreat where the participants reflect our diverse society? How can we re-imagine and re-construct decision-making processes and current structures so that future Sangha leaders, OI members and teachers in our Beloved Community reflect our society? How do we awaken together?

Last March 2017, ARISE presented to the Dharma Teacher Caretaking Council a set of recommendations prepared by the ARISE People of Color (POC) subgroup. We strongly encourage the review of these recommendations and that action be taken upon these recommendations. We are grateful for activities many of you have undertaken, individually and collectively, to advance the work of white awareness and to understand race, power and privilege. We believe that this work is absolutely critical for the future of our Mahasangha. In a recent survey of the U.S. Order of Interbeing members, 84% identified as White European heritage, among other findings.

To help move matters forward, we offer these inquiries:

- How do you see yourself, the Dharma Teachers body as a whole, and the Dharma Teacher Council helping ARISE fulfill its mission? (See Mission and Aspirations below.)
- How have you, the Dharma Teachers body as a whole, and the Dharma Teacher Council been working to address inclusion and intersectionality\* in our mahasangha?
- Are there ways that ARISE can help you, the Dharma Teachers body as a whole, and the Dharma Teacher Council in the work of inclusion and intersectionality?

- Creating safe and loving spaces for white allies of people of color to engage in looking deeply, understanding and healing from implicit bias and other forms of discrimination;
- Creating safe and loving spaces for white allies to understand the systemic legacy of racial inequity and to provide opportunities for learning and practice;
- Creating safe and loving spaces for people of color and white allies to come together to look deeply and engage in healing together;
- Looking deeply at and addressing the under-representation of people of color and low-income people in our individual Sanghas and the collective Sangha.

## Our Aspirations are to:

- 1) co-create a network within our sangha communities for practitioners who are interested in racial justice and racial and social equity issues;
- 2) encourage the sharing of resources and share information on articles, teachings, and practices on racial justice and racial and social equity;
- 3) co-create a sacred, courageous space for discussion and exchange on mindfulness and racial justice and racial and

social equity issues;

4) encourage diversity and inclusion in leadership within the mahasangha sangha and Order of Interbeing (OI) leadership; 5) Serve as a resource for sanghas and practice communities in the Plum Village tradition and beyond, sharing ideas and facilitating ARISE presentations at retreats, regular sangha gatherings, and other events.

<sup>\*</sup>Intersectionality – refers to how different forms of discrimination can combine, interact and overlap. Different forms of discrimination include gender, race, class, ability, sexual orientation, religion, caste, age, nationality and others. The term, intersectionality, was developed by Kimberle Crenshaw and can be used to understand how systemic injustice and social inequity occur on a multi-dimensional basis.
